IMPROVEMENTS UPDATE

In 2020, the resort continued improving and updating your resort with a budgeted amount of \$760,000.

The following is a list of the major reserve expenditures completed for 2020. Additionally, The Resort has entered into an agreement with Ryan Family Amusements to provide all the games and prize distribution machine which will enhance the resorts arcade experience. Upon town approval, the resort will be relocating the amusements in the RSC to the upstairs mezzanine area. As a result, the resort will need to comply with ADA accessibility requirements and will be installing a lift to service all three levels. Completion date is anticipated for early 2021.
