FROM YOUR GENERAL MANAGER

Dear Valued Owners,

I hope this message finds you well and enjoying the beauty of the Fall season as we are here at the resort. I'm excited to share some important updates and milestones over this past year that we've achieved together at The Cove at Yarmouth.

First and foremost, I want to extend a thank you to all who participated in the vote this past April regarding the Sunset Clause. I'm pleased to announce that it has been successfully passed and your Condominium documents have been amended to remove the provision that mandated our termination on January 20, 2025. The amendment ensures the long-term sustainability of your resort and the continuity of our community, allowing us to move forward with planned improvements that will benefit all owners.

Looking ahead, I'm thrilled to inform you that we will be commencing the second phase of renovations of our unit refurbishment project, targeting 52 units in the 400 and 500 buildings. These renovations are set to begin on December 1, 2024. We remain committed to upholding the high standards that you expect, and those who have stayed in previously upgraded units have given overwhelming positive feedback about the comfort and significantly improved appearance.

In response to the growing demand for electric vehicle accommodations, we have begun the installation of 10 EV charging stations on our property. This includes 4 rapid charging stations, which will fully charge vehicles in approximately one hour, and 6 trickle chargers for overnight use. We anticipate completion of this project by January 2025 and are excited to support our eco-conscious owners and guests with this new amenity.

Many of you have inquired about the generator located outside the A3 door. I'd like to clarify that this is actually our own natural gas power plant. This generator allows us to save approximately 4 cents per kilowatt-hour compared to electricity supplied by Eversource. This initiative not only helps us manage utility costs and provide back-up power, but also reduces our overall environmental footprint.

Lastly, I am proud to announce that The Cove at Yarmouth has been recognized as the Best Resort on Cape Cod based on a recent survey conducted by the Cape Cod Times. This accolade is a testament to our dedicated staff and your continued support as owners. We are grateful for your commitment and as we are equally committed to delivering the exceptional experiences that earned us this honor.

The Board and management's unwavering commitment to quality and excellence has made The Cove at Yarmouth the best resort to own, vacation and work at. On behalf of the entire staff, we wish you and your families many happy vacations and unforgettable experiences.
